These values demonstrate Synergy's commitment to eliminating modern slavery practices and describe how activities have and will be undertaken to mitigate risks of those practices in supply chains. For twenty-five years Synergy has prided itself as being a leader in the provision of Government professional services and is committed to supporting the *Modern Slavery Act 2018* (Cth). Synergy strongly supports governmental mechanisms aimed at addressing violations of human rights.

This Statement outlines Synergy's operations and supply chains, modern slavery risks, actions taken by Synergy in the reporting period (FY25), the effectiveness of those actions and the approach taken during our third reporting period. This Statement sets out the current state of operations and identifies areas of remediation and improvement.

This Statement is backed by Synergy's steadfast commitment to consistent and continuous improvement, and a willingness to recognise the risks in our current state and to undertake the necessary actions to minimise and mitigate those risks.


2 Reporting Entities

This Modern Slavery Statement ("Statement") is made on behalf of Synergy Group Australia Holdings Pty Ltd (ABN 38 662 711 551), and the wholly owned subsidiaries Synergy Group Australia Pty Ltd (ABN 65 119 369 827) and Synergy Group Law Pty Ltd (ABN 27 654 575 569), and ThinkPlace Australia Pty Ltd (ABN 28 673 168 244) (collectively "Synergy") for the financial year closing 30 June 2025. This is Synergy's forth Modern Slavery statement, which is made pursuant to section 14 of the Modern Slavery Act 2018 (Cth).

3 Organisational Structure, Operations and Supply Chain

Organisational Structure

Synergy Group Australia Holdings Pty Ltd, Synergy Group Australia Pty Ltd, Synergy Group Law Pty Ltd and ThinkPlace Australia Pty Ltd are managed centrally in Canberra. Essentially, these entities operate as one entity in similar industry sectors and are pragmatically controlled by the same board, share the same management, vendors and corporate functions including procurement, finance, information technology, human resources and legal. As such, this Statement is made on behalf of these entities.



Operations

Synergy operates across Australia with two offices in the ACT (Barton), one office in Victoria (Melbourne), one office in Sydney and a small, serviced office in Brisbane, as well as staff working remotely from other locations. Synergy employed approximately 451 permanent staff and in the financial year ending 30 June 2025 met the threshold for reporting.

Synergy has nine separate business lines, alongside an enabling National Business Services branch. A brief description of each business line is below:

CFO: The CFO capability aims to be a strategic partner for Government agencies' Chief Finance Officers (CFOs) and business units. A core capability of CFO is to provide financial management services to Government agencies. The CFO capability empowers CFOs through the timely provision of information and business insights.

Defence and National Security: The team is comprised of highly skilled policy experts, strategists, communicators, and capability planners. The team works with clients to apply expertise, analysis and ideas supporting decision-makers who deliver the right outcome to answer the needs of the current strategic environment.

Governance, Performance and Assurance: With over 40 multidisciplinary professionals who work across three core services: Performance and Governance, Organisational Resilience and Improvement and Audit. Governance, Performance and Assurance work with our clients to build trust, confidence, and certainty through robust and reliable advice, insights and foresights to strengthen an organisation's ability to create, protect and sustain value.

Program Design and Delivery: This service line is home to capabilities and professional career pathways for portfolio, program and project management and organisational change management. We are a leading delivery partner for government programs and projects in Defence and as well as other Federal Government agencies.

Synergy's Clients

Synergy's key clients are Australian Commonwealth Government agencies, with the Commonwealth constituting the majority of Synergy's clientele. Synergy also provides services to state and territory governments, private sector businesses and not-for-profit organisations.

Suppliers

Location of Suppliers

In preparing our fourth Modern Slavery Statement (FY25), Synergy assessed all suppliers regardless of spend.

Synergy understands that Tier 1 suppliers are those with whom Synergy has a direct contract. Tier 2 suppliers are considered the suppliers of Synergy's key contractors and subcontractors, and Tier 3 suppliers are the subcontractors or contractors of the Tier 2 suppliers, etc.


98% of Synergy's Tier 1 suppliers are located domestically within Australia, with two Tier 2 supplier located in India and China, which is used for textiles or marketing products.

Synergy's investment in the domestic market, by sourcing suppliers locally, is reflective of the business and vision of Synergy, which is committed to the investment and interests of Australia.

Types of Suppliers

Synergy Group's top 50 suppliers by spend all occur within low-risk sectors. 98.3% of spend occurs in low-risk sectors, with the remainder in moderate-low or moderate risk sectors. No spend occurs in moderate-high or high-risk sectors. Synergy has a small number of suppliers, 304 in total and therefore the risk is reduced by having long-term supplier relationships. Synergy's major suppliers in terms of their proportion of cost of the reporting period are outlined below:

4 Risks

Australia has a robust legislative framework criminalising trafficking of persons, slavery and slavery-like practices. Slavery-like practices include servitude, forced labour, and deceptive recruiting. Offences apply to public sphere exploitative labour practices and exploitation in the private sphere.

Australia's commitment to prevent slavery-like practices is reflected in legislation protecting victims of modern slavery. For example, victims of modern slavery may be protected under the vulnerable witness protection program (Crimes Act 1914 (Cth)) and Criminal Code Act (1995)). Additionally, the Migration Act 1958 (Cth) provides for offences for allowing persons to work in breach of visa conditions, as well as allowing victims who do not hold a valid visa to remain lawfully in Australia.

The Modern Slavery Act 2018 (Cth) establishes a risk-based framework to target modern slavery practices in supply chains, further supporting Australia's commitment to prevent slavery-like practices.

Analysis of Synergy's Supply Chain

Seventy one percent of Synergy's supply chain expenditure is on independent contractors.

The assessed risk of modern slavery in this context is lower than in scenarios involving unskilled or migrant labour. Additionally, the contractors we engage are educated professionals, all holding Australian citizenship and a minimum baseline security clearance. Australia's strong legal framework, supported by robust labour laws, minimises the risk of exploitative practices in our operations.

In undertaking an assessment of its remaining supply chain, Synergy engaged Fair Supply, an ESG data provider consultancy firm, to assist with assessing Synergy's supply chain and mitigating our risk. We applied the initial risk assessment methodology to our suppliers. This baseline exercise provides the basis for our subsequent focus for ongoing due diligence and remediation activities across not only the present reporting period but for upcoming years.

Incorporating company spend data throughout global markets, we have utilised Fair Supply's proprietary technology to trace the economic inputs required to produce products and services sourced from Tier 1 suppliers to Tier 2 suppliers, Tier 2 suppliers to Tier 3 suppliers, and so on, all the way to Tier 10 suppliers of the supply chain of Synergy's top suppliers by spend.

This supply chain mapping was performed using a balanced, global Multi-Regional Input-Output (MRIO) table which links supply chain data from 190 countries, and in relation to 15,909 industry sectors. This MRIO table is assembled using the following sources:

- a. The United Nations' (UN) System of National Accounts;
- b. UN COMTRADE databases;
- c. Eurostat databases;
- d. The Institute of Developing Economies, Japan External Trade Organisation (IDE/JETRO); and
- e. Numerous National Agencies including the Australian Bureau of Statistics.

The MRIO is then examined against the following international standards:

- a. The UN Guiding Principles on Business and Human Rights;
- b. The Global Slavery Index;
- c. International Labour Organisation (ILO) Global Estimates of Modern Slavery; and
- d. The United States' Reports on International Child Labour and Forced Labour.

A proprietary algorithm has then been applied to synthesise publicly available risk data against the exclusively licensed MRIO table. The result of this process is the creation of a modern slavery risk profile to Tier 10 for each supplier. This analysis was performed for the purposes of risk identification under the Act. It does not suggest to confirm the actual existence (or non-existence) of slavery in Synergy's supply chains and operations. Analysis was undertaken at the industry and country level. It does not account for variances at the entity, region or product level.

Of the 304 total suppliers assessed, 45 were identified as a moderate low risk and 256 were identified as low risk. These ratings assess the severity of the risk of modern slavery in a company and its supply chains at the industry level. Synergy's overall modern slavery risk is assessed as low.

5 Our Actions and Approach

Whilst instances of modern slavery practices were not identified in Synergy's operations and supply chain during this reporting period, Synergy will continue to diligently work with Fair Supply and our suppliers, to ensure that instances of modern slavery practices do not arise in future supply chains.

We will look to issue a Modern Slavery supplier questionnaire to new suppliers during this reporting period. Results of the questionnaire enable Fair Supply to evaluate and score the company's efforts to address modern slavery risk, and then provide an adjusted risk rating, based on the company's Industry risk rating and risk mitigation score.

Synergy has developed a Modern Slavery Hub on our Intranet. It provides training modules, awareness, learning resources and a toolkit for staff. In November 2023, Synergy launched a new L&D platform with a mandatory Modern Slavery awareness module. Existing staff and contractors were required to complete the module and new staff and contractors must undertake it as part of their onboarding. The completion rate at the end of the reporting period was 98.19%.

Synergy implemented a Modern Slavery Policy applicable to Synergy, its controlled and related entities, and its suppliers. The Modern Slavery Policy is reviewed on an annual basis.

Synergy's National Business Services team is responsible for overseeing and implementing Synergy's commitment to eliminating and reducing the risk of modern slavery from its operations and supply chains. Additionally, the team is responsible for investigating, addressing and reporting on any potential modern slavery practices that may be associated with Synergy or its suppliers. The team is supported by key professionals with diverse experience across various fields, including human resources, finance, strategic sourcing, advisory, legal and assurance.

Continual Assessment of Effectiveness and Future Commitment

Synergy's Continual Assessment of Effectiveness

Synergy established a Modern Slavery Working Group tasked with the implementation of the Modern Slavery Policy and the development of associated procedures, including the compilation of resources to assist the Synergy community in meeting the objectives of the Modern Slavery Policy.

Synergy will assess the effectiveness of actions taken to mitigate modern slavery practices, including:

- the use, effectiveness, and ability to conduct due diligence processes and how these processes may be improved;
- the frequency of discussions around modern slavery in the workplace, including incidences where advice may be sought, or consideration is required.

Synergy will continue to conduct risk assessments related to modern slavery practices in its operations and supply chains and record identified risks in a register, the likelihood of occurrence and the potential consequence of the realisation of those risks, and how Synergy will manage those risks.

Synergy's work in this space is ongoing, and by committing to the continual monitoring of modern slavery risks and development of treatment actions and measures, Synergy will have an fundamental ability to assess the effectiveness actions.

Synergy's Future Commitments

While in this reporting period our overall risk is assessed as 'low,' we understand that there are steps and actions we can take to improve and strengthen our awareness, accountability, and compliance. We are committed to reducing the risks of and eliminating modern slavery.



Synergy's Future Actions

In our previous statements we broke down the high-level framework provided above into 8 Actions for Synergy to complete in order to tackle modern slavery risks. These actions will improve our approach to assessing and mitigating the risk of modern slavery, as well as strengthening our compliance and accountability mechanisms. We continue to undertake action aimed at increasing awareness, designed to enhance the knowledge of both employees and suppliers, on the challenges and risks of modern slavery. Progress on the 8 action items is set out below:
